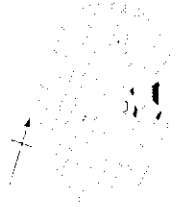

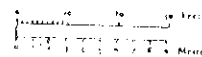
Description. The cairn is on the false crest of the hill at a little over 300ft. OD, in rough pasture which has been formerly under the plough. It has been greatly reduced, both in its diameters which are now 40 by 27ft., and in its height which is now 3ft. The entrance has been from the ENE but the passage has been completely removed. The tops of five stones are visible in the turf-covered mound, consisting of two pairs of transverse slabs and what is probably the end stone to the W. Of the outer pair of stones that to the N is the largest of the group, standing 2ft. 6in. high. Its partner, 1ft. 3in. to the S, is slight and only 9in. high. Three feet six inches behind is another pair 2ft. 6in. apart. The top of a slab leaning acutely towards the E can be seen only 2ft. further W and aligned between them, though its foot must be considerably further back.

The cairn lies only about 75ft. to the S of the long cairn of Gallow Hill, which is orientated at right angles to the axis of the chamber of this cairn.

440. *Chambered Cairn, Sordale Hill.*—Some 25 yards to the S. of the last are the remains of a round chambered cairn. Its diameter at the present time is some 34' and its elevation about 3'; but as the field in which it is situated has long been under cultivation, its dimensions have probably been considerably reduced. The entrance to the chamber has been from the WSW. At 21' inwards from the present edge a slab protrudes, which has evidently formed the back of the chamber. It is exposed for a height of 2' 8" above ground and measures 4' 5" in breadth and 1' 2" in thickness. Some 3' 7" in front of it the heads of two slabs in line and 2' 6" apart are visible, dividing the chamber. Though the chamber is ruined, there is no evidence of its having been excavated.
