the owner of the Monument known as **Setting of stones called "Standing Stones"** situated within an area measuring approximately 120 yards from north to south and 30 yards from west to east, 150 yards south of the point where the Burn of Thrumster flows out of the Loch of Yarrows and parallel to and 60 yards east of the east shore of the Loch of Yarrows,

being the subjects indicated in red colour on the annexed plan and being part of

the property known as **Brickigoe Croft (Thrumster Estate)**

situated in the Parish of **Wick,** and

County of **Caithness.**
